The school is required to shift Library in bigger room with minimum size of 112 sqm and upload the videography of the same on its website under mandatory disclosure section on its website. 4. The school is required to develop its play area and remove the debris/ construction material lying in the school premises. . 5. The school should ensure construction of ramps and toilets for CWSN students. 6.
